INTRO:

- 1. The activation of the GLO-JO P.A.L™ ZERO VIZ ASSIST™ Helmet Band (COB LED); should occur prior to ones arrival. This pre-arrival activation typically occurs during the donning of one's personal protective equipment (PPE).
- 2. Be advised... In freezing temperatures (>32 F), the silicon "On / Off" switch may stiffen, making it difficult to activate system. It is important to activate the system prior to entering freezing temperatures.
- 3. To ensure flawless operation, check battery power regularly. If system has not been used, charge at least once every 90 days. To charge system, utilize the USB charging cord provided & access USB plug-in area by carefully removing screw that secures rear LED panel. Once rear LED panel is removed, plug charging cord into USB Plug-in and let system charge until LED charging indicator light shuts off. (System will fully charge in approx. 2 hours; avoid letting system charge over night)

INSTALLATION:

- 1. Adjust your helmet band, achieving proper diameter using the helmet bands adjustability features (Left & Right Adjustability Buckle will allow one to lengthen or shorten strap as necessary).
- 2. Position the helmet band's LED so the "On / Off" switch is facing downward; toward helmets brim. The lettering "Personnel Accountability Locator" should be viewable on the top side.
- 3. Lastly, position the units CENTER SLOT within the CENTERLINE of your helmet.



To activate system or "Turn-On", press & hold the system against brim of helmet for 3 seconds (or press switch directly for 3 seconds). The system has 6 modes; hold button down for 1 second to change modes.

1st Mode
2nd Mode
100% Bright Blue (Primarily for Interior Use)
2nd Mode
100% Bright Violet (Primarily for Interior Use)

3rd Mode 100% Red Flash (Exterior Use Only - Long Duration)




5th Mode 100% Red (Exterior Use Only)

6th Mode 50% Red (Exterior Use Only - Long Duration)

To "Shut-Off" system, press & hold system against brim of helmet for 3 seconds (or press switch directly for 3 seconds); this will deactivate or Shut-Off the LED system.

**NOTE: The last Mode in which the system is Shut-Off, will become the same Mode in which the system is Turned-On.
